KC Stream Team Works to Update Conservation Plan by Melissa Reckner

The Kiski-Conemaugh Stream Team has been working to update the 1999 *Kiski-Conemaugh River Basin Conservation Plan* to quantify the changes in the watershed over the last 16 years through interviews with watershed organizations and conservation districts, review and status reports of the 120 recommendations in the original plan, and collection of chemical and biological water quality data to compare to historical data.

In 2015, the Stream Team completed 45 macroinvertebrate and 47 fish surveys, focusing on the streams on which AMD treatment systems have been constructed. Nine additional fish surveys were done in partnership with California University of Pennsylvania on the main stems of key rivers throughout the basin, since many had not been surveyed since the late 90s. While data are still being crunched, preliminary findings show that many of our rivers have seen an aquatic community shift as many waters are now net alkaline, meaning the acidity has been negated, and are more conducive to aquatic life. For example, in 1997, a fish survey found that the Conemaugh River in Seward was dominated by species that were pollution tolerant: blacknose dace, creek chubs, and white suckers. In 2015, the dominant species were pollution intolerant: banded darters and longnose dace. Additionally, a greater diversity of fish species was found in 2015 (9) than in 1997 (6).

This summer, the Stream Team will pull all the data together and prepare its report for dissemination this fall.

Funding for this project is provided primarily through a Community Conservation Partnerships Program grant for which the Cambria County Conservation and Recreation Authority served as a pass -through and a grant from the Foundation for Pennsylvania Watersheds.

I have even had the opportunity to travel to Bolivia and conduct research on the water chemistry and biological life of hypersaline lakes as well as collecting data on streams affected by mining.

At present, I am interning with Blair County Conservation District under Jim Eckenrode, the Watershed Specialist for Blair County. Our main focus lies in monitoring numerous sites along the Little Juniata River and its tributaries. By installing sondes (water tracking devices), we have continuous monitoring within 15 min intervals. Additionally, with the installment of a semi-permanent portable sampler, water chemistry and flow can now be conducted at baseline flow as well as during storm events.


