



AMD Treatment System Snapshot

A partnership effort has been organized to conduct two water quality snapshots of all publicly-funded passive treatment systems located within Pennsylvania. This snapshot will entail sampling of raw untreated AMD, the final effluent of the passive system, and the influent and effluent of every alkalinity-generating component feasible.

The first snapshot was scheduled for August and September 2009. The second is planned for late winter/ early spring (March, April, May 2010). A team consisting of individuals from PA DEP's Bureau of Abandoned Mine Reclamation (BAMR), Kiski-Conemaugh Stream Team, PA Senior Environmental Corps, Mill Creek Coalition, Babbs Creek Watershed Association, Broadtop Township, and Stream Restoration Inc. will conduct the monitoring. Funding for the snapshot is provided by a PA DEP Growing Greener Grant obtained by the Western Pennsylvania Coalition for Abandoned Mine Reclamation (WPCAMR).

Data from the snapshot will be made publicly available via Datashed, datashed.org, which is a free, web-based database designed to assist in the management of data related to passive treatment systems and stream monitoring for watershed groups, nonprofits, academia, government agencies and anyone else interested in passive treatment. In addition to the water monitoring data, other information regarding these passive systems, collected by PA DEP BAMR over the last year, will be uploaded to Datashed. An account is not necessary to view data; however, if you would like to be able to upload your own data, you can easily create an account by contacting Cliff Denholm or Shaun Busler at Stream Restoration Inc. at 724-776-0161.

Statewide Conference Highlights Region

The 11th Annual Statewide Abandoned Mine Reclamation and Coal Mining Heritage Conference was held July 13-16 at the University of Pittsburgh at Johnstown's Living Learning Center. This year's theme, "Challenges and Opportunities in Interesting Times," focused on renewing the collective energy of our state-wide patch town heritage and culture to become the new green communities of the future, as well as, looking into alternative renewable energy sources that can potentially be derived from abandoned mine lands and underground mine water pools. Over 160 people from at least three states and Nova Scotia attended the conference!

This region was well represented as the event kicked off with a tour of significant projects and places in the Stonycreek River Watershed, including White Water Park, Oven Run treatment systems, Flight 93, and the Windber Coal Heritage Center. Throughout the conference, local leaders gave presentations on topics such as the economic impact of watershed restoration on the Johnstown region, the potential to use the Incline Plane discharge for geothermal heating and cooling, and the economic costs and benefits of a fully restored Stonycreek River.

April 2010 will once again be Outdoor Heritage Month in PA's Allegheny Mountains. The planning committee met in June to discuss programming ideas and brainstorm outreach activities. In previous years, Outdoor Adventures, the school field trip, has been held toward the end of April, serving as one of the primary culminating



events of Outdoor Heritage Month. In 2010, Outdoor Adventures will be held May 6-7 due to extensive PSSA testing occurring throughout April in area schools. Still part of our Outdoor Heritage celebrations, the change in date only means a better chance for warmer weather during the event!
