Paddle the Que Event Makes a Big Splash!

With the growing interest in the paddling sports in the region, due in large part to the improved water quality in the Cambria-Somerset region, SCRIP in cooperation with the PA Fish and Boat Commission (PFBC) sponsored the Paddle the Que program at Summers Best Two Weeks at the Quemahoning Reservoir on August 18. The program is part of SCRIP's ongoing Stonycreek River of the Year commemoration events.

The educational event drew 81 men, women and children to learn paddling skills. The program is structured and taught by PFBC education professionals and provides instruction, education and hands on experience in paddling kayaks and canoes on flat water. Each of the participants were able to try out their new skills on the water.

SCRIP board members as well as members of the Benscreek Canoe Club were on hand to provide land and on the water coordination and assistance. Representatives from REI also attended and discussed products and other essentials for the paddling sports and SCRIP provided handouts and related material to the participants related to the water quality improvement efforts in the upper Conemaugh River Basin. *More on p.3*


Special Recognition Award from John Arway, PA Fish and Boat Commission Executive Director.

Natural Biodiversity Broadens Project on Jim Mayer Trail



who conducted a plant inventory of the buffer area.

The Jim Mayer Trail Riparian Restoration Project, a special program of Natural Biodiversity made possible with money from the Foundation for PA Watersheds GenOn funds and the Western Pennsylvania Conservancy's Dominion Watershed Mini-Grant Program, centered on improving and restoring a riparian buffer along a two mile section of the trail that runs along the Stonycreek River. The plan included control of knotweed and restoring the area by planting local, native trees and seeds most likely to prevent the re-establishment of the Japanese knotweed. To help determine the native plants in the area, Natural Biodiversity partnered with the Environment/ Conservation Committee of the Garden Club of Johnstown (GCJ),

Knotweed controlled cutting took place over four work days throughout the summer. On these same days, the GCJ surveyed the plants along the trail. The results of the inventory included: forty native and thirty non-native plants. There were five other plants that could not be clearly identified; the exact species could not be determined or it was unclear if the plants were native or introduced. The completed inventory will help Natural Biodiversity, under its Executive Director, Kristina Strosnider, determine the best plants and seed mix to use in restoring the riparian area after the knotweed removal project is completed. This will help further the goals of the project to restore the area, control erosion and improve the water quality along the Stonycreek River.


