Stonycreek-Conemaugh River Improvement Project Make Use of Our Rivers

Lion Mining AMD Treatment System on the Bens Creek Completed

The long awaited reconstruction of the Lion Mining AMD Treatment System along the South Fork of the Bens Creek in Somerset County is complete. The project was designed by Eric Robertson of the Pennsylvania Association of Conservation Districts Design Team and assisted by Brent Means of the federal Office of Surface Mining. The project was funded from forfeited bond money and a Growing Greener grant administered by the PA Department of Environmental Protection (PA DEP). The total construction cost was \$550.000.00.

The system replaces a smaller less effective system that could not properly treat the discharge. The breakout that created the need for the initial treatment system initially harmed the water quality and aquatic life in the Bens Creek when it broke out a number of years ago. Biological survey work performed by the Somerset Conservation District in recent years demonstrated that the aquatic life has recovered from that initial surge. However, although the former treatment site prevented catastrophic damage, it was never the long term answer. The new treatment system is situated on the other side of Route 281 and is designed to treat up to a 1,000 GPM discharge by connecting the new treatment site with 1600 feet of pipe of gravity flow water from the mine bore hole.

The water flows to a large settling basin and then to a series of wetlands and deep water gardens before discharging into the South Fork of the Bens Creek. A pavilion, trail and a parking lot have also been constructed at the site. The system is discharging less than one mg/l of iron.

The land for the project was donated by Kim and Mary Beth Rauch and the site was constructed by Earthshapers LLC of Ebensburg. The PA DEP plans a formal dedication of the system later this year.

Allegheny Mountain Green Fest Green Your Routine





Many in our society have clearly recognized that our current way of life is unsustainable. If we care

SCRIP will also award the grand prize winner a special prize, which in the past has been a trolling motor. You don't need a boat to participate, as shore fishing will again be permitted this year within the cove near the public recreation area.

Ameri Corps and HR 1: A Perspective

Jobs. Jobs. Jobs. That is what we always hear that we need. Then why will we allow our United States Congressional elected officials to eliminate over 650,000 jobs in this country in the holy name of budget cuts?

Well, that is what they are considering with HR 1 that would eliminate the Corporation for National and Community Service that oversees a long list of valid and essential national service programs.

The services that these programs provide empower non-profits of all types, hospitals, schools and other cash strapped institutions to serve the human needs of students, young, middle aged and senior citizens and the economically disadvantaged all while putting to work mostly young 18-25 year olds who most need employment and job training opportunities all while accomplishing human resource tasks that the private sector does not allow for.

If HR 1 passes the immediate direct impact in Pennsylvania alone would be that more than 6,500 young people will lose Foster Grandparents, 2,400 homebound seniors will lose Senior Companions and 3,100 groups will lose Retired Senior Volunteer Program volunteers who conduct safety patrols, protect the environment and respond to disasters. The lingering and indirect impacts will be even much worse.

The Ameri Corps program is one shining example of the many programs that may be extinguished. Since 1994 over 34,000 Ameri Corps members in Pennsylvania contributed 43 million hours of service to a wide range of essential organizations and their clients. In the local region 1,454 members have served through the Pennsylvania Mountain Service Corps (PMSC) contributing 1,993,650 hours that has brought \$15,474,951.00 of federal dollars into our region. The PMSC serves 95 different non-profits and schools each year with Ameri Corps members that provide invaluable public services that otherwise

would never exist.

In addition to the services the on the job training that Ameri Corps members receive has led them to be much more employable by both the public and private sectors when their Ameri Corps service ends.

As an Ameri Corps site sponsor supervisor (for which I receive no monetary compensation for by the way) for many years I can personally attest to the tremendous returns on investment of the Ameri Corps program. In the conservation sector alone many of the natural resource conservation projects that are now hailed as some our greatest economic incentives and improvements never thought possible in our region would not have occurred without the contributions of the Ameri Corps program in the Cambria-Somerset region. I have also watched these members then enter the public and private work force with ease because of the skills they learned in Ameri Corps and attain higher paying jobs than my own.

To cut or even reduce a program with this type of track record that addresses and does something about our employment issues and service needs is reaching an erroneous conclusion in the name of today's hype and rhetoric created by an uninformed and uncaring minority in this country.

Here is a news flash for them and everyone else. Not all government is bad. So let's cure the problem by cutting the fat out of government, not the meat. Otherwise we will surely cure ourselves to an untimely and unneeded catastrophic reduction in our health, our way of life and our future.
