## Stonycreek-Conemaugh River Improvement Project Make Use of Our Rivers

### Two Brine Water Injection Wells Found in Somerset County

Thanks to the investigative efforts of the Somerset Conservation District a "discovery" was made in regard to the location of two brine water injection wells both located in the Stonycreek River watershed. According to the Environmental Protection Agency (EPA), that is the primary permitting agency for injections wells in Pennsylvania, there are eight such injection wells in the state. It just so happens that two of them are in Somerset County.

According to information received by the District from the EPA, one well is owned by Cottonwood and the other by CNX (Consol). It was also revealed that the wells were originally drilled as shallow gas wells, but have been operating as deep injection wells for many years.

The EPA requires analysis of the wells every two years and relies on the company's own reporting to supply the information and data to the EPA in regard to what is actually being introduced into the wells. The EPA has one well inspector for the state.

The injection wells deposit their fluids approximately 8,000 feet deep into the Oriskany Sandstone formation. The Oriskany is located just below the Marcellus Shale formation.

According to the EPA tracking and monitoring, the pressures produced in the injection wells are essential to keeping the waste material from migrating elsewhere. Unlike the fracturing process often used in Marcellus Shale well drilling, the injection wells are not permitted to produce pressures that fracture the Oriskany Formation. The injection fluids must travel only through the fissures that already exist in the Orsikany Formation.

The Conservation District has received annual reports on the wells that have information and data on both wells courtesy of the EPA. The District is currently analyzing that information.

Recently researchers at Columbia University have studied earthquakes in Ohio and have pointed to a deep injection well as the probable cause of an earthquake that shook Youngstown, Ohio on New Year's Eve.

No such situation has been attributed to any of the injection wells in Pennsylvania to this point. However, the EPA is currently in the process of permitting additional injection wells in Warren County that are under appeal because of concerns raised by citizens in that area.

In addition, it seems to appear that citizens, the conservation community and decision makers locally in the Cambria-Somerset region had no idea that these injection wells were in operation in the Stonycreek River watershed. The Somerset Conservation District and SCRIP will continue to work with the EPA and other entities involved to attempt to make the injection well process a more open and information friendly procedure in the near future.



### Paint Creek Watershed Clean-Up Scheduled For March 31

#### Paddle the Que Event Slated for This Summer



SCRIP board members have decided to hold a *Paddle the Que* event this summer modeled after the Pennsylvania Fish and Boat Commission *Paddle PAI* Program. The goal of the program is to introduce participants to basic paddle skills and safety awareness.

The program usually includes three 10 minute sessions on life jacket and water safety, hazards to paddlers and paddling safety, and pad-

dle skills. At the end of the instruction period, participants will have some free paddle time.

PA Fish and Boat Commission staff will lead the workshops and the canoes and kayaks will be provided for the participants. Advance registration will be required.

### Saint Francis University Faculty and Students Available to Help Local Watershed Groups by William Strosnider, Ph.D.

The Environmental Engineering Department at Saint Francis University has recently won support from the Foundation for Pennsylvania Watersheds to assist nonprofit watershed restoration organiused to establish the Watershed Restoration Amplification Program (WRAP). Via WRAP, SFU professors and students will be using real class projects, research teams, service-learning internships, and volunteer events to assist local watershed restoration nonprofit organizations. Examples of the type of assistance that can be provided include:

- Website development
- Fundraising material creation
- Press releases
- Grant writing
- Data collection
- Data analysis
- Engineering design advisory
- Trash removal events
- Troubleshooting engineering problems
- And any other task that helps a watershed restoration nonprofit organization

The nonprofit partners currently include: the Kiski-Conemaugh Stream Team, Natural Biodiversity, Shade Creek Watershed Association, FracTracker, Sandyvale Memorial Gardens, and SCRIP. 
#### Grants Awarded to Area Environmental Groups by Melissa Reckner

The Coldwater Heritage Partnership recently awarded grants to the Conemaugh Valley Conservancy / Kiski-Conemaugh Stream Team and Somerset Conservation District to prepare coldwater conservation plans for Beaverdam Run and tributaries of the North Fork of the Bens Creek, respectively. The goals of these grants are to build local awareness and support for the preservation of coldwater streams and their watersheds. Both groups will neering) as associate directors.
