My name is **Jonathan Graffius** and I was the recipient of the \$500 SCRIP scholarship. I am currently a senior Environmental Engineering major with a concentration in Renewable Energy at Saint Francis University and will be graduating in May 2016. Along my path through Saint Francis University I was lucky enough to have two internships where I learned a lot about the real world and our environment.

My first internship was with the Blair County Conservation District where I really learned about water quality and what our streams provide for the ecosystems and ultimately us. I learned how beneficial volunteer programs are in protecting our rivers and streams. These volunteers care about their local community whether it be preserving a trout stream or assisting to help clean up an acid mine drainage impacted river. I was also able to help educate elementary to high school students about the impacts that they can have on the environment with their day to day activities and what they can do to be more environmentally friendly.

My second internship was with P. Joseph Lehman consulting engineers where I learned groundwater sampling techniques. I learned that not all polluted waters are surface waters (such as lakes and streams), but can also be located in the groundwater. This pollution can come from leaky underground storage tanks which contain gasoline. This is important to us because many people rely on drinking wells as their main source of drinking water and can be negatively affected by this pollution.

Upon graduation in May I will hopefully obtain a job in a local consulting firm where I can use my engineering education to help design remediation systems that will benefit my community. I would ultimately like to work for a renewable energy company in the future.

SCRIP \$500 Scholarship

The Stonycreek Conemaugh River Improvement Project will be awarding a \$500 Scholarship to a worthy student for the current academic year. Deadline to submit is March 30, 2016.

Eligibility—Applicant must:

Either be a dues-paying SCRIP member or the child of a SCRIP member

Reside in one of the counties that includes the Kiski-Conemaugh Basin (Armstrong, Cambria, Indiana, Somerset, or Westmoreland). Residency means the student lives in or is a resident at a school in one of these counties.

Be in an accredited environmental field of study at a Pennsylvania college or university.

How to Apply:

The application should contain these three parts:

- **Part I** A cover sheet with the following information: name, mailing address, email address, phone number, college or university attending, year and course of study
- **Part II-** A typed statement, double-spaced, 12 pt font size, no longer than two pages explaining applicant's professional goals, how the course of study will meet those goals and any involvement to date in the field.


Part III- A copy of applicant's latest transcript

Applications must be received by March 30, 2016. Please send to: SCRIP, Scholarship 2016, P.O.Box 164, Windber, PA 15963. Award notification will be no later than April 30, 2016. Award check will be sent directly to the Financial Aid Office at the college or university.

Award recipient will be required to inform SCRIP of his or her personal academic achievements, graduation and future career plans in article form for publication in the SCRIP newsletter. This information will be used to assist with promotion of any future SCRIP scholarship awards.
